

# PRIVACY POLICY

## 1. General

We inform you that the Company for Services KSNM TECHNOLOGIES LLC Skopje (hereinafter: Play4Win) takes all available technical and organizational measures, in order to ensure the protection of the personal data that you voluntarily share with us.

Play4Win strives for you to be fully and clearly informed regarding the processing of personal data when you visit our website and use our services.

Read this Privacy Policy carefully to become fully aware of its contents before giving your consent for processing your personal data.

## 2. Definitions

The terms in this Policy are defined as in the Law on General Data Protection:

**“Personal data”** means any information relating to an identified or identifiable natural person (data subject); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as the first and last name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person;

**“Processing of personal data”** means any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as: collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, inquiry, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction;

**“Restriction of processing”** means the marking of stored personal data with the aim of limiting their processing in the future;

**“Controller”** means the natural or legal person, state administration body, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of personal data. Where the purposes and means of such processing are determined by a law or another regulation, the law or regulation shall stipulate the controller or the specific criteria for its nomination;

**“Third party”** means a natural or legal person, state administration body, public authority, agency or another body other than the data subject, controller, processor or

person who, under the direct authority of the controller or processor, is authorized to process personal data;

“**Consent**” of the data subject means any freely given, specific, informed and unambiguous indication of the data subject's wishes by which he or she, by a statement or by a clear affirmative action, signifies agreement to the processing of personal data relating to him or her;

“**Direct marketing**” means any type of communication taking place by any means with the purpose of imparting advertising, marketing or publicity materials targeting directly a specific data subject, as well as personal data processing which includes profiling to the extent that it is related to this type of communication.

#### 2. Basis and objectives for processing and categories of personal data that we process

Your consent represents a basis for the processing of your personal data which you share with Play4Win, i.e. you give consent for the processing of your personal data in the “login” section, in order to participate in prize games, customer club and / or marketing activities if it is approved by the user, as well as technical optimization and monitoring of the site.

Play4Win collects the following categories of personal data in the “login” section:

Name and surname;

Telephone number;

E-mail;

Technical data at each visit as operating system, browser,

Your data is shared with third parties / extensions like Google, MailChimp, Facebook.

### 3. Time limit for storage of the personal data

Your data is stored on a server that has a firewall, SSL encryption and is regularly scanned for malware and kept until the purpose for which it was given, until the user unsubscribes

### 4. Cookies

The webpage Play4Win uses cookies.

“Cookie” is a file that contains an identifier that is sent from a web server to a web browser and stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server

The cookies can be “permanent” cookies or session cookies: permanent cookies that will be stored by the web browser and remain valid until the expiration date, unless the user deletes them before the expiration date; a session cookie, on the other hand, will expire at the end of the user session when the web browser is closed.

Cookies may not contain information that personally identify the user, but the personal data we hold about you may be related to information stored and received from the Cookies.

### 5. Your rights as a subject for personal data protection

As a subject of personal data protection, you have the right to be informed about the processing of your personal data, the right of access to your personal data, the right to correct your personal data, the right to delete your personal data, the right to restrict the

processing of your personal data personal data, the right to object to the processing of your personal data, as well as the right to withdraw the consent given to Play4Win for the processing of your personal data.
